We request that you confirm your availability prior to submitting your application.

PERFORMANCE GUIDELINES

- Each performance group is designated a twenty (20) minute time slot on stage. This includes set-up, performance and tear down.
- Please arrive as a group no less than fifteen (15) minutes prior to your scheduled time and be at the stage area ready to perform as scheduled. Depending on time, late arrivals may be unable to perform or receive a shortened time slot.
- The members of your group are responsible for their set-up and tear down before and after your performance, under supervision of the Stage Manager.
- The cafeteria and gym stages are equipped with a sound system and microphone.
- Performances, including costumes and attire, must be appropriate for all ages.
- Speeches will not be eligible for stage time.
- **Taste of Trinity 13** is a rain or shine event.
- The **Seven Springs Middle School PTO** reserves the right to photograph/videotape activities, and performance participants for potential future use without compensation. All photos/footage will remain the property of Taste of Trinity and may be used for publicity or promotion purposes only.
- The location of the Performers/Performances (Gym or Cafeteria) will be at the sole discretion of the SSMS PTO based on logistics and compatibility.
- The STAGE PERFORMANCE FORM is due on or before **March 15, 2023**.
